Minutes of the meeting of Over Haddon Parish Council held at Over Haddon Village Hall at 8:00 pm on Monday 8th November 2021

- 658 Declaration of Members Interests
Interests declared in respect of this meeting: 2 councillors noted their interest as active allotment holders and abstained from the vote on fees to allow the motion to pass.
- 659 Public Speaking
a) Members of the public – highlighted the poor Environmental stance of DDDC in not reinstating the food bin collections yet and discussed assistance with the next phase of the Plantation.
b) PCSO Morris and CCllr Alasdair Sutton sent apologies. DCllr Alison Hill and DCllr Mark Wakeman attended and advised on Giving Page barcode donations, County Council dieback grants and that Remembrance Parade road closures now rest with local councils not the British Legion. They noted concerns about bin collections with the hope that normality will resume in the new year.

663 Highways and Footpaths

Potholes and Gennel – the County Councillor is to be chased for a new meeting date.
DDDC Carpark entrance laurel hedge needs cutting back by DDDC.

664 Allotment vacancies and renewals under revised contract

Council agreed the reallocation of plots and the new contracts will be sent to all shortly. A community orchard half plot was agreed and sponsored for its first year by DCllr M Wakeman. Council resolved to increase the ½ plot price to £15 per year from 1st January 2022 – other sizes pro-rata.

665 The Plantation

The site meeting outlined areas requiring completion and local volunteers were thanked for the 5 sessions put in to date. Thanks were given to everyone involved by the Vice-Chair.

Access from the Highways mown triangle has PDNPA officer approval and just needs Highways approval for access paving and reduced mowing commitment. There are enough materials from current stocks to carry this out.

With the receipts now in all grant monies have been spent.

Phase 2 – a timber stone bench construct was approved and the history group is to provide copy for a panel. DDDC councillors to be asked for funds to cover this phase.

666 Fibre Broadband

50 addresses and phone numbers have been listed and Openreach will be contacted to see if this is enough to cover the upgrade costs. It was noted that a few properties at the Bakewell end have fibre to the door already available but Openreach haven't marketed this so occupants were unaware.

667 DDDC toilet Block and Car Park

The cleaner situation remains unresolved – winter cleaning 1 per week in operation.

The car park cash machines now have access to a mobile app payment system.
